Post-Legislative Scrutiny Manual

I. Purpose

This manual was created to implement the resolution of the National Assembly Standing Committee on the Post-Legislative Scrutiny (PLS) No. 53/KPC, dated August 23rd, 2022. It is an introduction, explanation about the procedures and approaches in the implementation of the work of PLS to be a reference for the committees of the National Assembly working uniformly.

II. Contents

The PLS has the following main content:

1. Promoting, publicizing, and raising awareness of respect for the law;
2. Drafting or implementation mechanism of the law, including the development of articles of law into legislation under the law;
3. Reviewing the law in some articles that have some conflicting content, gaps, effects or causes that cannot be implemented;
4. The results of the implementation of the law including challenges, causes and lessons learned.

III. Procedures and Approaches

1. Procedure

1.1. Formulating a Post-Legislative Scrutiny Plan

Formulating a concept note/plan to oversight and evaluate the legislation implementation shall proceed as follows:

- 1.) The Law Committee, in cooperation with the National Assembly's committee, consider and draft a PLS plan to oversight and evaluate the legislation implementation of the National Assembly Standing Committee on an annual or periodical basis;
- 2.) After completing the draft plan for oversight and evaluate the legislation implementation of the National Assembly Standing Committee, Law Committee sent the draft plan to other related committees of the National Assembly for their considerations and comments;
- 3.) The Law Committee revised the draft plan on oversight and evaluate the legislation implementation of the National Assembly Standing Committee base on comments from other committee of the National Assembly and report to the National Assembly Standing Committee to consider and adopt the plan;
- 4.) The relevant committees of the National Assembly expand the PLS plan of the National Assembly Standing Committee

into their own oversight and evaluation of the legislation implementation plan.

For the detailed outline of the plan for oversight and evaluation of the legislation implementation of the National Assembly's committee, it is defined in V of this manual.

1.2. Conducting the Post-Legislative Scrutiny

The oversight and evaluation of the implementation of the law by the committee of the National Assembly shall be carried out as follows:

- 1) After completing the PLS plan, then consider and prepare documents such as proposal letter, guidelines, format, questions, and other documents;
- 2) Send proposal letter, guidelines, format, questions, and other documents including the PLS plan to the government agency responsible for evaluating the implementation of the law in order to consider, prepare and evaluate the implementation of the law;
- 3) Liaise and coordinate with government agencies responsible for evaluating the implementation of laws and other relevant agencies;
- 4) Monitor and promote PLS by holding a joint meeting with the government agency responsible for the evaluation of the implementation of the law and collecting data in some localities;
- 5) Summarize the results of overseeing and evaluation of the implementation of the law;
- 6) Draft report on the results of overseeing and evaluation of the implementation of the law.

1.3. Reporting and Considering the Result of the Post-Legislative Scrutiny

Reporting and considering the results of the monitoring and evaluation of the implementation of the law in the National Assembly Standing Committee meeting and the National Assembly meeting shall be carried out as follows:

a. Reporting and Considering the Result of the Post-Legislative Scrutiny in the National Assembly Standing Committee Meeting

- 1) The President of the Law Committee or the president of the relevant committee is the one who reports the results of the monitoring and evaluation of the implementation of the law;
- 2) The chairman of the meeting has a comment;
- 3) The meeting participants provide comment or raise questions on the report of the results of the oversight and evaluation of the legislation implementation;
- 4) State agencies responsible for evaluating the implementation of laws clarifying or answering the questions that have been raised;
- 5) The chairman of the meeting has a summary and proposed for the meeting to adopt.

b. Reporting and Considering the Result of the Post-Legislative Scrutiny in the meeting of the National Assembly

- 1) The President of the State, the government, the Supreme People's Court, the Supreme People's Prosecutor's Office, the State Audit Organization, the State Inspection Organization, the Lao Front for National Development, the Lao National Veterans Federation and central mass organizations report on the evaluation of the implementation of the law under their responsibility;
- 2) The National Assembly Standing Committee provide comment;
- 3) The chairman of the meeting has a comment;
- 4) Members of the National Assembly provide comments or raise questions;
- 5) State agencies responsible for evaluating the implementation of laws clarifying or answering the questions that have been raised;
- 6) The meeting voted to adopt.

For the reporting and consideration of the evaluation of the implementation of the law in the field of the National Assembly, the following should be done:

- 1) The National Assembly Standing Committee reports;
- 2) The chairman of the meeting comments;
- 3) National Assembly Members have comments or ask questions;
- 4) The National Assembly Standing Committee clarified or answered the questions raised;
- 5) The meeting voted to adopt.

2. Approaches

The monitoring and evaluation of the implementation of the law has the following approaches:

4) Collection of actual information

Collect actual information as follows:

- The report of the organization evaluating the legislation implementation;
- Provision of information of those who are directly affected by the implementation of the law;
- Information collection through the hotline of the National Assembly;
- Information collection at the actual location;
Requesting information from other sectors

5) Information collection with targeted inquiries

Information collection with targeted inquiries should be done as follows:

- Face-to-face questioning or interviews;
- Questioning through print form;
- Questioning through electronic media.

6) Conduct a meeting

The meeting should be organized as follows:

- Oversight targets report;
- The chairman of the meeting has comments;
- Meeting participants have comments;
- Oversight targets clarified, explained;
- The chairman of the meeting has a summary and provide some directives.

- Pursuant to the Law on the Legislation Making (Amended), No. 06/NA, dated 16 November 2021;
- Pursuant to the Law on the Amendment of Some Articles of the Law on the National Assembly and the Law on the Provincial People's Assembly, No. 82/NA, dated 30 June 2020.

To ensure that the oversight and evaluation of the legislation implementation is carried out in accordance with the rules and the procedures, unified and effectively implemented.

The Standing Committee of the National Assembly agreed:

Chapter 1 General Provision

Article 1 Purpose

The resolution determines the principles, regulations, and procedures regarding the oversight and evaluation of the legislation implementation in order for the work to be carried out in a continuous and efficient manner to ensure that the promulgated legislations are strictly implemented.

Article 2 Oversight and Evaluation of the Legislation Implementation

The Post-Legislative scrutiny is the oversight and evaluation of the implementation of laws of the government organization.

Article 3 Principles of the Post-Legislative scrutiny

In the Post-Legislative scrutiny activity, the following should be done:

1. Strictly comply with the law;
2. Ensure transparency, disclosure, coordination with relevant sectors, promote democracy and gather opinions widely;
3. Be clear, fair and timely;
4. Participation of the public and the media.

Chapter 2

Post-Legislative scrutiny

Article 4 Responsibility for the Post-Legislative scrutiny.

The National Assembly Standing Committee oversees the evaluation of the legislation implementation by assigning the Law Committee as a focal coordinating with other relevant committee of the National Assembly.

Article 5 Responsibilities of the Law Committee.

In overseeing, monitoring and evaluating the legislation implementation, the Law committee has the following responsibilities:

1. Consider and formulate an annual plan for monitoring and evaluating the legislation implementation to present to the National Assembly Standing Committee for consideration;
2. Coordinating with the National Assembly committees to monitor and promote the evaluation of the legislation implementation of the sector in the area in which it is responsible;
3. Participate in monitoring, promoting the evaluation of the legislation implementation of the sectors in the areas that other committee of the National Assembly are responsible for;
4. Summarize and brief the work of evaluating the legal implementation of the sector in the area of responsibility to report to the Standing Committee of the National Assembly.

Article 6 Responsibilities of other committees of the National Assembly

In oversight and evaluating the legislation implementation, other committees of the National Assembly have the following responsibilities:

1. Review, comment on the annual plan for oversight and evaluating the legislation implementation;
2. Monitor and promote the evaluation of the legislation implementation of the sector in the area in which it is responsible;
3. Summarize and brief the work of evaluating the legal implementation of the sector in the area of its responsibility to report to the Standing Committee of the National Assembly.

Chapter 3

Contents, Procedures, Approaches for Oversight and Evaluating the Legislation Implementation

Article 7 Contents of the Post-Legislative Scrutiny

The main content is as follows:

1. Publicizing and raising awareness of respect for the law;
2. The drafting or implementation mechanism of the law, including the development into a detailed legislation under the law;
3. Checking the law in some articles that have some conflicting content, gap, has an effect or cause that can not be implemented.

Article 8 Procedures for the Post-Legislative Scrutiny

The oversight and evaluation of the legislation implementation follows the following steps:

1. Formulating a plan to oversight and evaluate the implementation of the law;
2. Oversee and evaluate the implementation of the law;
3. Report and consider the findings of oversight and evaluation of the implementation of the law.

Article 9 Approaches of the Post-Legislative Scrutiny

The oversight and evaluation of the legislation implementation has the following approaches:

1. **Collect actual information**
2. **Question the targets**
3. **Conduct a meeting**

The details of the procedures and approaches are defined in the manual for monitoring and evaluating the implementation of the law.

Article 10 Results of monitoring and evaluation of the implementation of the law

After the meeting of the National Assembly considers and approves the results of the monitoring and evaluation of the implementation of the law, the relevant government agencies are brought to amend according to the resolution of the National Assembly.

Chapter 4 Final Provisions

Article 11 Implementation

The committees of the National Assembly and related sectors shall recognize and strictly implement this resolution.

Article 12 Effectiveness

This resolution is enters into force from the date of signing.
